

Victim's Rights and Services

Welcome to Cherish Child Advocacy Center!

The Cherish Center is a Nationally Accredited Child Advocacy Center (CAC). We are a neutral, safe place where children and teens can talk. We provide interviews, advocacy, referrals and community trainings.

The Cherish Center partners with a team of professionals called the Multidisciplinary Team (MDT), which helps the child avoid having to tell their story over and over. The MDT will be observing the interview from a closed-circuit camera at The Cherish Center.

Interview:

A professionally trained forensic interviewer will speak with your child one-on-one to make them feel as comfortable as possible and to maintain the integrity of the process. Although called an interview, it will feel more like a conversation. The interview is developmentally appropriate, non-leading and non-traumatic. The MDT will be observing the interview as it is happening. At the end of the interview, a representative from the MDT may speak with you about their process moving forward.

Advocacy:

A family advocate will be present with you during the child's interview. They can answer your questions, provide education, emotional support, and refer for services. This could be trauma therapy, medical services, or other needed community resources.

After your visit today, the advocate will follow up with you about any ongoing needs that your family may have via phone call, email, or text.

Although the advocate will reach out, please feel free to contact them!

Please let your family advocate know if there is anything you need, or we can do to help you feel more comfortable.



Know Your Rights:

According to Indiana Code Title 35, Article 40, Chapter 5, all victims have the:

- Right to be treated with fairness, dignity and respect.
- Right to freedom from intimidation, harassment and abuse throughout the criminal process.
- Right to be informed upon request about release of escape from custody of the perpetrator.
- Right to confer with the prosecutor's office.
- Right to have 'safety of victim' be considered in determining perpetrator's release from custody.
- Right to be heard at any proceeding involving sentencing or release via oral or written statement.
- Right to pursue an order of restitution
- Right to information about criminal case or perpetrator
- Right to be informed about victim's rights.
- Right to an electronic transcript of an appeal.

Sexual Assault Nurse Examination (SANE)

The purpose of the SANE is to assess the health and well-being of the child in a quiet, safe and secure environment. A SANE will never be forced, and all control is left to the child. The goal of the exam is to reassure that everything is okay with the child's body, treat medical conditions that may or may not be related to child abuse, while providing emotional support and age-appropriate communication.

The nurse will recommend appropriate follow up, provide resources, and meet individually with caregivers to discuss any concerns and to review exam findings.

The Center for Hope Clinic at Peyton Manning Children's Hospital

Community Hospital- Anderson

Visit the ER or call 765-298-5598 to schedule or to speak with a member of the team.

Community Hospital will only assess sexual assault.



Statewide Automated Victim Information and Notification (SAVIN)

The Indiana SAVIN program is a free, automated hotline that provides crime victims with vital information and notification 24 hours a day, 365 days a year. This service will allow individuals to obtain offender information and to register for notification of a change in offender status, such as offender release. The Indiana Violent Crime Victim Compensation Fund through Indiana Criminal Justice Institute strives to assist victims, or their dependents, with certain costs as a direct result of a violent crime. These funds can assist with medical bills, mental health counseling, lost wages, and other unforeseen circumstances related to the crime.
